

Life term given in abuse of woman, 95

A judge imposes consecutive year sentence for burglary.

Man with an extensive

criminal history was sentenced Thursday to life plus 30 years in prison for assault and battering a 95-year-old woman and burning her home. Danny Ray Wilson, 52, of Tulsa pleaded no contest in

April to two felonies - first-degree burglary and aggravated assault and battery.

He did not have an agreement with prosecutors regarding his punishment.

District Judge William Kellogg imposed a life term for

When he was arrested after being spotted walking a couple of blocks away, he was carrying a BB gun that matched the description of the gun the victim said had been taken, police reported.

When asked for his version of events for the Department

of Corrections background report, Wilson replied that he "can't remember because I was passed out," that report says.

Wilson indicated that he was heavily under the influence of alcohol and had smoked crack cocaine before

the offense, the report says.

Thorp said Wilson has 14 previous felony convictions, including five for burglary.

The other nine are for unauthorized use of a vehicle, larceny of merchandise from a retailer, making a false declaration of ownership in a pawn action, concealing stolen property, robbery, a drug

offense, and three for possessing a firearm as a felon, records indicate.

Wilson has been in the Tulsa Jail since Aug. 29.
